

Dear Residency Applicant,

Thank you for your interest in our Postgraduate Year One (PGY1) Pharmacy Residency at Sanford USD Medical Center in Sioux Falls, South Dakota.

Sanford USD Medical Center's PGY1 Pharmacy Residency Program is ASHP-accredited and is designed to provide exceptional, tailored experiential learning while facilitating professional growth and development of the pharmacy resident. Our program structure includes required 4-week experiences in Internal Medicine, Pediatrics, Critical Care, Anticoagulation, Medication Safety, Transition Month, Project-Focused, and Precepting. Required longitudinal experiences include Administration/Practice Management, Drug Information, Education, Service, and Project-Longitudinal. We offer a breadth of elective learning experiences including Emergency Medicine, Pharmacogenomics, Infectious Disease, Nephrology/Transplant, Oncology, Neonatology, Cardiology, Ambulatory Anticoagulation, Critical Care II, Internal Medicine II, and Pediatrics II. We strive to customize the residency year and learning experiences to each resident's individual needs and pride ourselves on the flexibility necessary to provide this customization.

Each resident is required to complete a large-scale project over the course of the year and will attend the ASHP Midyear Clinical Meeting, SDSHP Annual Meeting, and the Midwest Residency Conference, all as part of the residency program requirements. Our residents provide decentralized pharmacy services every third weekend. This includes pharmacokinetic monitoring, anticoagulation management, renal dose adjustments and order verification.

We collaborate with the South Dakota State University College of Pharmacy to provide our residents with opportunities to teach and precept students through the completion of a Teaching Certificate Program. This is a required longitudinal experience for our residents and is coordinated by SDSU College of Pharmacy.

Residents are provided paid health and vision insurance and 20 days of Allowed Time Away (ATA). The resident stipend is competitive and updated annually.

- Letter of intent (include clinical areas of interest and reason for pursuing a residency)
- Current Curriculum Vitae
- College transcript(s)
- Three reference submissions

**All application materials and deadlines will be managed through PhORCAS.**

We require an on-site interview for all qualified applicants. Virtual interviews may be considered. Interviews will be conducted with multiple candidates each day and will include a case review and presentation by each applicant.
